STRATFORD CITY COUNCIL REGULAR MEETING February 13, 2023

The Stratford City Council met for a budget work session on Monday, February 13, 2023, with Mayor Larry Runyan calling the meeting to order at 6:30 p.m. at City Hall.

Council and City Manager Leeds reviewed the general fund and Fiscal Year 2024 Budget. No action was taken at this session.

Keith Halleland of YSS of Hamilton County was present to give city council an overall summary of what been happening at YSS.

City Manager Leeds and council held a short discussion on the west Tennyson Avenue watermain breaks. City Manager Leeds explain to the council that currently there is \$141,421.66 roughly left from the previous watermain project, borrowed at 2.95%. Jim Leiding, P.E., of Bolton & Menk, Inc was available to review the west Tennyson Avenue Water Main Improvements. The Engineer's Opinion of Probable Costs for the project is \$103,980.00. Leiding went over the construction plans with council. The project consists of replacement of four hundred -fifty linear feet of six-inch watermain, five service connections, one hydrant assembly, valves and abandonment of the existing watermain.

City Manager and council held a lengthy discussion about the property tax valuations that will affect the fiscal year 2024 budget. During the 2021 legislative session, the Iowa Department of Revenue proposed legislation to remove the multi-residential property tax assessment classification. The proposed legislation was passed, and signed into law by Governor Reynolds on March 8, 2021, and was to go into effect for property assessment beginning January 1, 2022. Iowa Senate has introduced Senate File 181 which corrects an unintended issue with 2021 Iowa Acts legislation. It reduces the residential rollback by 1.8% from 56.49% to 54.65% It would require the Department of Revenue to recalculate residential rollback for the assessment year 2022. Currently, this bill has passed the senate 49-0 with an amendment. The amendment moves the deadline for submission of the budget to April 30, 2023. This new deadline would apply to only fiscal year 2023-2024 budget submission and would apply to all local governments. It has not passed the house yet, but something to keep our eye on.
